<ul style="list-style-type: none"> <li>Active</li> <li>Stipulation</li> </ul>	Based on a review of your application, you are <b>ELIGIBLE to volunteer in the presence of an OCPS employee</b> at all times.
<ul style="list-style-type: none"> <li>Active Requested</li> </ul>	Based on a review of your application, you are <b>ELIGIBLE to volunteer in the presence of an OCPS employee</b> at all times. <u>A background check for more advanced volunteering opportunities has been requested and is being processed.</u>
<ul style="list-style-type: none"> <li>Approved</li> <li>Law Enforcement</li> <li>OCPS Consultant</li> <li>OCPS Employee</li> <li>OCPS Substitute</li> <li>Passed</li> </ul>	Based on a <b>review of your application</b> , you are <b>ELIGIBLE</b> to volunteer, Mentor or Tutor. <ul style="list-style-type: none"> <li>May Not Chaperone</li> </ul>	Based on a review of your application you are ELIGIBLE to volunteer in the <u>immediate presence of an OCPS employee</u> at all times with the following <b>STIPULATIONS</b> : <b>You may not:</b> <ul style="list-style-type: none"> <li>mentor</li> <li>tutor</li> <li>chaperone</li> <li>transport other students</li> <li>have access to OCPS and/or any school-related financial transactions or property transactions</li> </ul>
<ul style="list-style-type: none"> <li>May Volunteer with their Child only</li> </ul>	Based on a review of your application, you are <b>ELIGIBLE to only accompany your own child in the immediate presence of an OCPS employee</b> at all times. <b>You may not:</b> <ul style="list-style-type: none"> <li>volunteer in a group setting with children other than your own</li> <li>mentor</li> <li>tutor</li> <li>chaperone other students</li> <li>transport other students</li> <li>have access to OCPS and/or any school-related financial transactions or property transactions</li> </ul>
<ul style="list-style-type: none"> <li>May Not Handle Money</li> </ul>	Based on a review of your application you are ELIGIBLE to volunteer with the <b>STIPULATION that you MAY NOT HANDLE MONEY</b> . Therefore, you may not have access to any OCPS and/or any school-related financial and/or property transactions in any volunteer capacity.
<ul style="list-style-type: none"> <li>May Not Transport</li> </ul>	Based on a review of your application, you are ELIGIBLE to volunteer, however; you <b>MAY NOT TRANSPORT STUDENTS</b> in any OCPS volunteer capacity.

<ul style="list-style-type: none"> <li>Prohibited</li> <li>May Not Volunteer</li> </ul>	You are <b>INELIGIBLE</b> to volunteer. Volunteer ineligibility may be based on criminal history, not adhering to OCPS Policy and/or Volunteer Guidelines, or other criteria.
<ul style="list-style-type: none"> <li>Appeal</li> </ul>	Your appeal is pending Legal Services review. Please know this can take up to four weeks.
<ul style="list-style-type: none"> <li>District Use Only</li> </ul>	Your application is being reviewed by the District Office.
<b>PARTNERS IN EDUCATION APPLICATION STATUSES</b>	
<ul style="list-style-type: none"> <li>Partner-Active</li> </ul>	Based on a review of your application, you are ELIGIBLE to be a Partner in Education. Partners in Education employees/representatives <b>going on a school campus must complete the <u>ADDitions School Volunteer application</u></b> .
<ul style="list-style-type: none"> <li>Partner-Inactive</li> </ul>	Business or organization is <b>NO LONGER</b> partnering with a school or <b>INELIGIBLE</b> to be a Partner in Education. Ineligibility may be based on not adhering to OCPS Policy and/or Volunteer Guidelines, criminal history, or other criteria.
